### School Facility Conditions and Planned Improvements

The district takes great efforts to ensure that all schools are clean, safe, and functional through proper facilities maintenance and campus supervision. Sycamore Canyon School's original facilities were built in 1961; ongoing maintenance and campus improvements ensure facilities remain up-to-date and provide adequate space for students and staff. District maintenance and site custodial staff ensure that the repairs necessary to keep the school in good condition are completed in a timely manner. A work order process is used by school and district staff to communicate non-routine maintenance requests. Emergency repairs are given the highest priority. Sycamore Canyon's campus was modernized in 2009. Solar Ready replacement lunch court structures were installed in 2017. The district added a new-single story learning resource center with large open collaborative spaces in spring, 2021.

#### **Professional Development**

All training and curriculum development activities at Sycamore Canyon School support the implementation of Common Core Content Standards and State curricular frameworks. Roughly 70% of these days are partial days of professional learning (1-3.5 hours each). Decisions concerning selection of staff development activities are performed by the principal, district administrators, and grade level representatives using tools such as teacher input, district benchmark results, data analysis, and focus groups to determine the areas in which additional teacher training may enhance classroom instruction and increase student achievement levels. Sycamore Canyon School offers support to new and veteran teachers through peer coaching and mentoring. All staff are encouraged to attend professional workshops and conferences. Classified support staff receive job related training from department supervisors and district representatives.
