All training and curriculum development activities at Carlton Oaks School support the implementation of Common Core Content Standards and State curricular frameworks. Teachers annually individually receive between 3 - 5 days of release time for professional development at the site and/or district level. All staff are encouraged to attend professional workshops and conferences including GLADD, CGI, Restorative Practices, Open Sci-Ed, and CPI. Approximately 70% of our Staff Development is done on a partial day and approximately 30% is a full day of Staff Development. Decisions concerning selection of staff development activities are performed by the principal, district administrators, and grade level representatives using tools such as teacher input, district benchmark results, data analysis, and focus groups to determine the areas in which additional teacher training may enhance classroom instruction and increase student achievement levels. Carlton Oaks School offers support to new and veteran teachers through peer coaching and mentoring. All staff are encouraged to attend professional workshops and conferences. Classified support staff receive job related training from department supervisors and district representatives.
