All training and curriculum development activities at Sycamore Canyon School support the implementation of Common Core Content Standards and State curricular frameworks. Roughly 70% of these days are partial days of professional learning (1-3.5 hours each). Decisions concerning selection of staff development activities are performed by the principal, district administrators, and grade level representatives using tools such as teacher input, district benchmark results, data analysis, and focus groups to determine the areas in which additional teacher training may enhance classroom instruction and increase student achievement levels. Sycamore Canyon School offers support to new and veteran teachers through peer coaching and mentoring. All staff are encouraged to attend professional workshops and conferences. Classified support staff receive job related training from department supervisors and district representatives.
